### **The responsibilities:**

### **The Job Descriptions:**

- Implement operational procedures and guidelines on HCML field wellhead platform to ensure the achievement of production targets and pre-determined specifications in alignment with HCML policies and government regulations.
- Review Maintenance procedures from Maintenance team and vendors to be implemented in WHP Operations to ensure future effective wellhead platform activities and compliance to HCML procedures.
- Supervise maintenance activities and critical function testing for all equipment and its report according to maintenance schedule and operations procedure to ensure that all equipment's are available and reliable.
- Direct troubleshooting process when equipment failure occurs.
- Participate in process or risk assessments and root cause analyses related to the WHP in order to provide input for process improvement and contribute to the mitigation of operational risks.
- Provide input to the operational and shutdown plans of WHP, provide direction and monitoring of production regarding execution and timely resolution of issues which impair operating efficiency / production.
- Ensure preventive maintenance (PM) delivery and set-up planning and scheduling of corrective maintenance (CM) activities in WHP.
- Ensure that all activities on the platform comply with Health, Safety and Environment policies and procedures.

- Ensure that all field activities, improvements, and non-conformances are adequately documented and readily available to optimize the knowledge management.
- Perform good coordination and communication with gas buyers.
- Support communication of production, operational, and maintenance activities to local governments and local communities.
- Manage employees' development through succession planning, training programs, performance management, and other related HR related programs to ensure operational excellence and achieving department's goal.
